Volunteer Emergency Medical Technician (First Responder) Organization Fees*

- Initial application - \$150.00

* This is a new fee. EMTs who claim volunteer status must be affiliated with a Volunteer EMT Organization and will not pay for initial license or license renewal. An organization that files for volunteer EMT status will pay a fee of \$150.00 for a two-year period.

Exam Fees*

- EMT - \$80.00
- Advanced EMT - \$105.00
- Paramedic - \$125.00

* This fee includes the initial psychomotor exam and up to, and including, two re-test attempts. This eliminates retesting fees and streamlines the psychomotor examination fees.

Exam Site Fee*

- \$500.00

*An agency can apply to become an exam site. A \$500.00 application fee is submitted for a two-year period.

Examiner Fee*

- \$25.00

*An EMS practitioner may take an examiner course to become a certified examiner for a two-year period.

Volunteer Fee Exempt Status

Fee exemption is allowed ONLY if you volunteer exclusively for a LICENSED provider or REGISTERED first responder organization (receive no pay from ANY service for providing EMS care). This does not include reimbursement for actual expenses for medical supplies, gasoline, clothing, meals and insurance incurred while volunteering. The EMS administrator is required to complete the Volunteer Sign-off section on your certification/licensure application.

If you submit an application fee, it will be considered a declaration of non-exempt fee status. Volunteers are not exempt from fees when applying for inactive
